What is Global Technical Assistance Mechanism *for* Nutrition?

A common global approach endorsed by over 40 Global Nutrition Cluster partners to provide systematic, predictable, timely and coordinated nutrition technical support to countries in order to meet the nutrition rights and needs of people affected by emergencies. The Global Technical Assistance Mechanism for Nutrition (GTAM) is co-led by UNICEF as the Cluster Lead Agency & World Vision.

What is the composition of the Global Technical Assistance Mechanism *for* Nutrition?

The GTAM is composed of a core team that includes UNICEF, World Vision, Emergency Nutrition Network, Technical Rapid Response Team, and the Global Nutrition Cluster Coordinating Team. The core team works with nutrition partners and with existing Global Thematic Working Groups (GTWG) to meet the country technical needs. Some examples of existing GTWGs that the GTAM would engage with include, the Infant Feeding in Emergencies (IFE) Core Group, No Wasted Lives,

Cash Learning Partnership (CaLP), The Council for Research and Technical Advice on Acute Malnutrition

Why Global Technical Assistance Mechanism *for* Nutrition?

A glaring absence of leadership and coordinated approach among global partners in providing technical support to countries on nutrition in emergencies was experienced by many stakeholders. This was also confirmed in two studies^{1,2}. In order to avoid duplication of efforts, limited technical coherence, delayed and inadequate response to country nutrition technical needs, the GTAM therefore aims to:

- Provide coherent technical guidance across a range of resources
- Facilitate easy access to technical resources
- Ensure that countries are able to secure technical support at the right time
- Effectively meet country technical advice and guidance needs in real time
- Bring order and excellence to the provision of technical support to countries

What does the Global Technical Assistance Mechanism *for* Nutrition do?

When country and regional capacities are exhausted, any unresolved technical issues will be escalated to the GTAM.

Depending on the issue, the GTAM will:

Provide technical advice

Provide feedback to questions from individuals working in countries in emergencies within a relatively short timeframe, primarily when normative guidance exists and is available.

Facilitate consensus driven guidance

Identify and address the need for developing interim operational guidance in order to enable a specific emergency response.

Provide specialized technical expertise

Secure specific technical expertise that a country needs in order to deliver results for nutrition. The technical expertise support might be in form of deployments or remote support of technical staff as well as capacity building.

What are the benefits of the Global Technical Assistance Mechanism *for* Nutrition?

Provides a platform for countries to access technical resources

Leverages and maximizes existing global, regional and country capacity

Provides a clear & predictable process to efficiently respond to the technical needs of NiE practitioners

Reduces time NiE practitioners take to find a technical resource
